

MINUTES OF A MEETING OF
THE CLARKSVILLE TOWN COUNCIL
HELD ON MAY 17, 2010

A meeting of the Clarksville Town Council was called to order on May 17, 2010, at 7:00 P.M. in the meeting room of the Clarksville Municipal Center Administration Building by Council President Gregory Isgrigg, who chaired the meeting.

Council members present: Gregory Isgrigg, Paul Kraft, Vicki Appleby, Raymond Richert, Donald Tetley, and Bob Popp. Council members absent: David Fisher. Also present at the meeting: Assistant Fire Chief Thomas Upton, Police Chief Dwight Ingle, Street Commissioner Donnie Hansford, Director of Engineering & Stormwater Tom Clevidence, Mike Otto representing the Town's wastewater treatment facility management firm, Planning Director Sharon Wilson, Grant Writer Brittany Montgomery, Code Enforcement Officer Jeff Spainhour, Parks Superintendent Brian Kaluzny, Council Administrative Assistant Trish Fraser, Town Attorney Chris Sturgeon, and Natalie McLochlin.

Approval of Minutes... A motion was made by Council Member Kraft to approve the minutes of the executive session of the council held on May 3, 2010. The motion was seconded by Council Member Appleby and carried by unanimous vote. A motion was made by Council member Appleby to approve the minutes of the regular meeting of the council held on May 3, 2010. The motion was seconded by Council member Kraft and carried by unanimous vote.

Announcement from President Isgrigg... Council president Isgrigg announced that he had received a thank you note from Tammy Evans with Jeffersonville Band Boosters for being able to use the south parking lot for a flower sale.

Resident Only Parking Requests... Tammy Durbin resident of 741 N. McKinley Avenue in Clarksville came before the Council requesting a resident only parking sign for one spot in front of her residence. A motion was made by Council member Richert to approve the resident parking sign. The motion was seconded by Council member Appleby and carried by unanimous vote.

Maritza Canizales resident of 745 N. McKinley Avenue in Clarksville came before the Council requesting a resident only parking sign for one spot in front of her residence. A motion was made by Council member Kraft to approve the resident parking sign. The motion was seconded by Council member Popp and carried by unanimous vote.

Adoption of Ordinance 2010-S-03... Following the presentation of a proposed Ordinance by Town Attorney Sturgeon numbered 2010-S-03, amending salary ordinance 2010-S-01, appointing an Interim Building Inspector and an increase in salary for two code enforcement officers, a motion was made by Council member Appleby to consider Ordinance 2010-S-03 for adoption on its first reading at this meeting. The motion was seconded by Council member Richert and carried by unanimous vote. A motion was made by Council member Appleby to adopt Ordinance 2010-S-03. The motion was seconded by Council member Richert and carried by unanimous vote.

Adoption of Resolution 2010-R-05 Declaring Areas of Eastern Boulevard Corridor to be Areas in Need of Redevelopment... Following the presentation and discussion of the proposed resolution declaring areas of Eastern Boulevard corridor to be areas in need of redevelopment, a motion was made by Council member Tetley to adopt resolution 2010-R-05. The motion was seconded by Council member Kraft, and carried by unanimous vote.

Resident's Concern with Flooding on Maple Court... Beth Dorsey resident of 120 E. Maple Court in Clarksville came before the council with her ongoing concerns and damages from the flooding on Maple Court wanting to know what was being done on the situation. Ms. Montgomery, Ms. Wilson and Mr. Hart with Jacobi, Toomz, and Lanz explained to her what all was being done and the Town was still in the process of resolving the flooding issues.

Department Reports... Mr. Clevidence announced that the work being done on Brown Station way was going to last for two more weeks.

Council Comments... Mr. Popp announced that T.J. Maxx would be opening on Sunday.

Approval of Claims... Accounts payable registers presented for approval consisted of Town pre-approved claims issued 5/4/2010 through 5/17/2010 in the amount of \$254,114.33, Town current claims in the amount of \$92,720.97, Wastewater/Stormwater utility pre-approved claims issued 5/3/2010 through 5/7/2010 in the amount of \$20,844.75, Wastewater/Stormwater utility current claims in the amount of \$424,167.93, Town and Wastewater/Stormwater utility gross payroll issued 4/23/2010 in the amount of \$318,351.52, and Town and Wastewater/Stormwater utility gross payroll, including pension benefits, issued 5/7/2010 in the amount of \$355,804.54. A motion was made by Council Member Kraft to approve the accounts payable registers presented. The motion was seconded by Council Member Appleby and carried by unanimous vote.

Adjournment... There being no further business to come before the Council at this time, on a motion made by Council Member Kraft seconded by Council Member Appleby and carried by unanimous vote, the May 17, 2010 meeting of the Clarksville Town Council was adjourned at 7:43P.M.
