

MINUTES OF A WORK SESSION OF THE CLARKSVILLE  
TOWN COUNCIL HELD ON APRIL 3, 2018

A work session of the Clarksville Town Council was called to order on April 3, 2018 at 7:55 P.M. in the Council Chambers of the Clarksville Municipal Center Administration Building by Council President Paul Fetter who chaired the meeting.

Council members present: Paul Fetter, Tim Hauber, David Worrall, David Fisher, Jennifer Voignier, and Aaron Stonecipher. Absent: John Gilkey.

**Discussion regarding Communities in Schools of Clark County request for Donation**

Discussion held regarding the request for funding from the Town. After further discussion it was decided more information was needed before a decision could be made. No action taken at this time.

**Presentation by Nick Lawrence of the Wheatley Group**

Nick Lawrence of the Wheatley Group came before the Council and gave a presentation regarding Economic Revitalization Areas and Economic Development Target Areas. Discussion was held and Council advised to bring to the next Council Meeting for a vote.

**Discussion of Wastewater Appeal**

Discussion was held regarding the Wastewater Appeal that was presented at the earlier Council Meeting. The recommendation of Utility Director Brittany Montgomery is to deny the appeal. Council was in agreement and the appeal denial will go through the formal process at the next Council Meeting.

**Discussion regarding using the phone numbers on hand at the Wastewater Billing Office for REACH ALERT**

Discussion was held regarding using the phone numbers of wastewater customers that the billing office has been provided to promote the use for the REACH ALERT PROGRAM, the emergency notification system the Town will begin using. After discussion, it was decided not to use the phone numbers of wastewater customers.

**Presentation of Renewal of Insurance**

Representatives from Neace Lukens came before the Council with preliminary insurance renewal costs. Discussion was held and it was advised the Insurance Committee would be meeting again on April 12, 2018 to review updated information and making a recommendation for Council consideration at the April 17, 2018 meeting. No decision was made at this time.
