

MINUTES OF A WORK SESSION OF THE CLARKSVILLE  
TOWN COUNCIL HELD ON MARCH 16, 2015

A work session of the Clarksville Town Council was called to order on March 02, 2015, at 7:33 P.M. in the executive conference room of the Clarksville Municipal Center Administration Building by Council President Bob Polston who chaired the meeting.

**Council members present:** Bob Polston, Paul Kraft, Don Tetley, John Gilkey, Bob Popp, Tim Hauber, Paul Fetter. Also present at the meeting Clerk Treasurer Robert Leuthart, Town Attorney Chris Sturgeon, Redevelopment Director Nick Lawrence, Administrative Assistant Anita Neeld, Police Chief Mark Palmer, Project Coordinator Brittany Montgomery, Building Commissioner Ilpo Majuri, Judge James Guilfoyle, and Deputy Clerk Sherry Lockard.

**Request to Purchase two (2) Raptor Systems for two elementary schools in Clarksville...**

Police Chief Palmer presented to the council a request to purchase two Raptor Systems, one for Clarksville Elementary and one for Parkwood Elementary. Chief Palmer stated the Raptor is a software database system with ID printing capability. The purpose of the software is to identify possible threats entering the schools. The database identifies sexual offenders, restraining and protective orders on individuals, court mandated removal and trespassed individuals. Chief Palmer advised the cost of each system is \$1600.00, with shipping, for a total of \$3200.00. Chief Palmer advised he would like to use the money in the locally seized drug fund money fund. The consensus of the council was to bring to the next meeting for a vote.

**Request to Purchase and Provide more security for the Town Hall...**

Judge Guilfoyle made a presentation to the Council to enhance security at Town Hall. Judge Guilfoyle advised he would like to see a portable metal detector installed and an employee to man the metal detector. Judge Guilfoyle advised the equipment would cost approximately \$5,000.00-\$6,000.00, but the manpower to man the metal detector will be a larger cost. Discussion was held regarding how this would be paid for and after further discussion, it was decided more information was needed before a decision or consensus could be made. Judge Guilfoyle advised he would obtain more detailed information for the Council.

**Adjournment**... There being no further business to come before the Council at this time, Council Member Kraft made a motion to adjourn, Council Member Fetter seconded the motion and was carried by unanimous vote. The meeting was adjourned at 8:15 P.M.
