

**MINUTES OF A REGULAR MEETING OF  
THE CLARKSVILLE TOWN COUNCIL HELD  
ON NOVEMBER 16, 2015**

A regular meeting of the Clarksville Town Council was called to order on November 16, 2015, at 7:00 P.M. in the Council Chambers of the Clarksville Municipal Center Administration Building by Council President Bob Polston who chaired the meeting.

-Council President Polston congratulated the incoming council and the Providence High School Volleyball team and stated we need to obtain a sign for them.

**Approval of Claims**... Accounts payable registers presented for approval consisted of Town current claims in the amount of \$236,810.92, Town pre-approved claims issued through 11/16/2015 in the amount of \$366,321.33, Wastewater/Stormwater utility current claims in the amount of \$27,875.34, Wastewater/Stormwater utility prewritten claims in the amount of \$15,456.33, SW Bond in the amount of \$810.00. Council Member Kraft made a motion to approve claims registers presented. Council Member Gilkey seconded the motion and was carried by unanimous vote.
