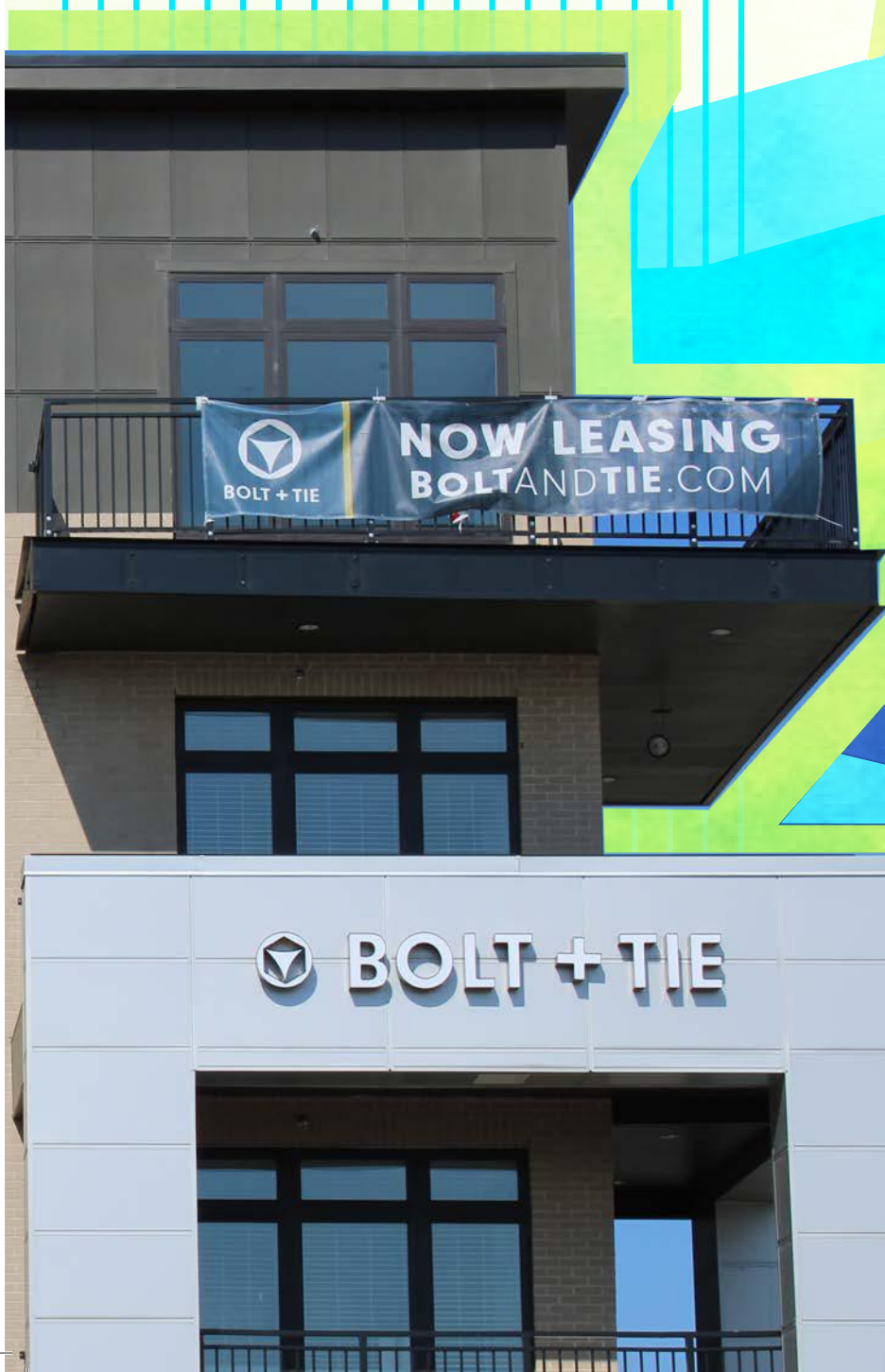

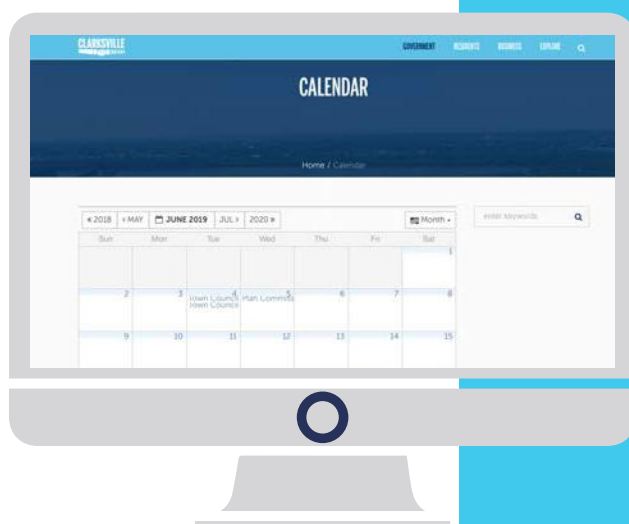

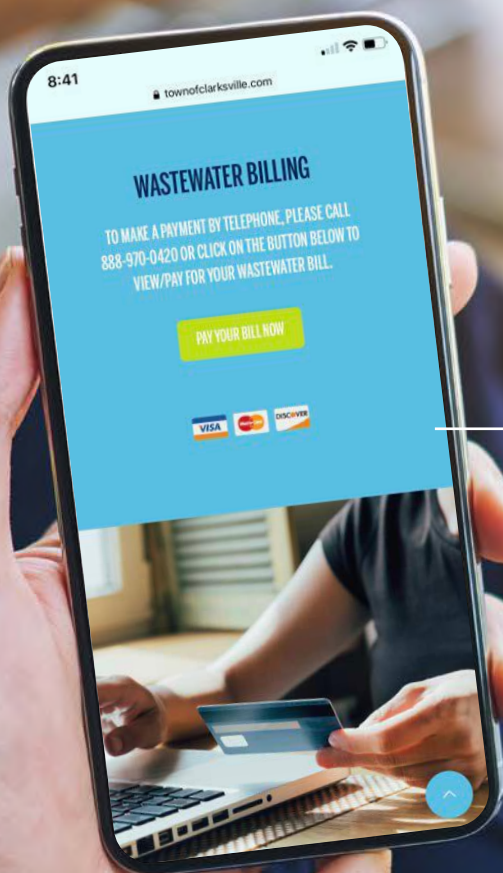

LEISURE WAY ROAD EXTENSION NOW OPEN

The Town of Clarksville has announced the completion of the Leisure Way extension project. This new road will better connect the busy thoroughfare of Veteran's Pkwy to Clarksville's hotel district, providing better access to three hotels and encouraging further development along the way. The \$1.8M project concludes on time and under budget after one year of construction.

CLARKSVILLE DONATES LOT TO HABITAT FOR HUMANITY FOR NEXT HOUSE

The Town of Clarksville has partnered with Habitat for Humanity Clark & Floyd Indiana to give a home to future Clarksville resident Donna Gray and her four-year-old daughter. In addition to land donated by the Town, Vectren Foundation awarded Habitat for Humanity CFI a \$60,000 grant to go towards the cost of the build.

The project is still in the beginning stages. The foundation footings have been poured by Messer Construction, a Habitat for Humanity CFI partner, and rough-in plumbing and other in-slab utility work will begin shortly.

Team members from Samtec, Heartland Payment Systems and members of the Habitat for Humanity CFI board have worked together to build panel walls that will be used to frame the house. The house is expected to be framed in July with the goal of having Donna and her daughter settled into their new home in time for the Holidays.

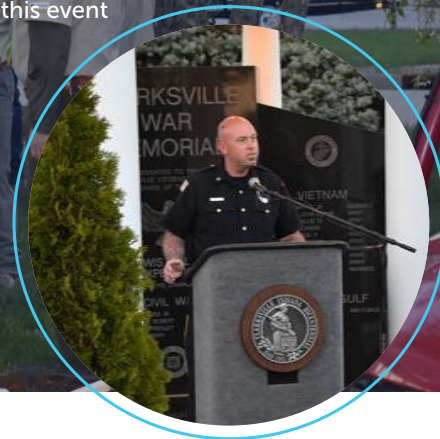

FLAG RETIREMENT CEREMONY

On April 17th, 2021, the Town of Clarksville, Boy Scouts Troop 10, Clarksville Fire Department and the Clarksville Police Department came together to perform the Town's first Flag Retirement Ceremony. The flags used in this ceremony were those collected through the Town's Flag Retirement Box.

This ceremony could not have been possible without the support of the Town Council, Boy Scout Troop 10 and Chief Brandon Skaggs of the Clarksville Fire Department. Thank you to all those who participated and made this event a success. The flag disposal box has been a great resource for the community. To date, it has collected close to 100 flags, all of which are burned per U.S. flag code.

Clarksville residents can retire their used and worn-out U.S. flags by placing them in the Flag Retirement Box located at the Clarksville Police Department. NEWBORN SAFELY SURRENDERED IN BABY BOX

A newborn baby was safely, legally and anonymously surrendered in a Safe Haven Baby Box at Fire Station #1 on May 2. Firefighters responded quickly and were able to transport the baby to a nearby hospital, where the baby was examined and found to be very healthy.

"The parent or parents of the child made a choice based on love and grace," said Clarksville Fire Chief, Brandon Skaggs. "With a dedicated team and available resources this choice has provided hope, love and a life for this child." The Baby Box was made available to the public last October thanks to the Town of Clarksville and Safe Haven Baby Boxes in an effort to provide a place for mothers in crisis to safely, securely and anonymously surrender if they are unable to care for their newborn.



"This mother loved this child and it takes a very special person to want what's best for a child and know that it's not her," said Monica Kelsey, founder of Safe Haven Baby Boxes. "That's the ultimate act of selflessness. I'm so thankful she chose a safe place to surrender her child and not in a dumpster or trash can like we see too many times." All infants surrendered under Indiana's safe haven law are released from the hospital and placed in the custody of the Department of Child Services. This starts the process for all safe haven babies to ensure they find an adoptive family within 30-45 days. **If you would like to adopt a safe haven baby, contact your local Department of Social Services and register as a foster/adoption family. There are thousands of kids in foster care looking for forever families.**

TOWN OF CLARKSVILLE RECEIVES \$800K GRANT FROM EPA TO CLEAN UP RIVERFRONT AND SOUTH CLARKSVILLE

This will benefit the entire region of Indiana and Kentucky,” said Town Redevelopment Commission President A.D. Stonecipher. “We expect this grant to create at least 80 jobs and as much as \$16M in impact in the next few years.

The U.S. Environmental Protection Agency (EPA) has announced that Indiana’s Town of Clarksville is receiving a \$800k Brownsfield Multipurpose Grant to conduct environmental site assessments and cleanup plans for Ohio Riverfront and South Clarksville properties.

“The Town of Clarksville is ecstatic to receive this multipurpose grant from the EPA and we intend to use the funds to help clean-up our riverfront on the mighty Ohio river for the enjoyment of all Clarksville, Southern Indiana, and Louisville, KY residents,” said Town Council President Ryan Ramsey. “The EPA’s buy-in is just another indicator that Clarksville is moving in the right direction. I’d like to extend my sincerest gratitude to the EPA’s leadership and frontline team for believing in Clarksville and investing in our town.”

The Brownsfield Multipurpose Grant supports underserved and economically disadvantaged communities in assessing and cleaning up contaminated and abandoned industrial and commercial properties. Approximately 50 percent of selected recipients will be receiving EPA Brownfields Grant funding for the first time with more than 85 percent located in or serving small communities, like the Town of Clarksville.

KEEP IT LOCAL: *Reeder's Cleaners*

In 1913, Reeder's Cleaners opened their doors on Spring St. in Jeffersonville, naming themselves after founder C.D. Reeder. After 44 years of providing dry cleaning services to the Southern Indiana community under Mr. Reeder's ownership, Joseph Nalley purchased the business in 1957. From then, the location moved to 1205 Eastern Blvd in Clarksville and stayed in the Nalley family for multiple generations.

Today, Joseph's grandchild Roman Nalley owns the business. Now, the full-service dry cleaner offers an assortment of services including fire and water damage restoration, wedding gown cleaning and preservation, bedding washing and more. For convenience, the shop even has a drive-thru where customers can drop off their garments without leaving their car. Reeder's Cleaners is known for their ability to work with many materials and to complete just about any cleaning job.

"If it's made out of fabric, furs or skin and you can fit it through our door, I can probably work on it," said Roman.

Roman says he grew up in the shop, learning the ropes from both his grandfather and father. However, nothing could have prepared him for the impacts the COVID-19 pandemic would have on a local business. He says the pandemic has been challenging.

"For a while, we were running under 20% our normal sales," said Roman. "We're still not back to normal because you still have people that don't go to work It's going to be tough. We're making it, but it's been very scary."

Roman says he has no plans to halt business operations in the near future. He says the reason Reeder's Cleaners is still moving forward is because of their trustworthiness and ability to do the job right.

NEIGHBORHOOD SPOTLIGHT

LINCOLN HEIGHTS NEIGHBORHOOD CELEBRATES NATIONAL HISTORIC RECOGNITION

The Lincoln Heights neighborhood was officially listed on the National Register of Historic Places on March 6, 2020. However, due to COVID-19 limitations, the Clarksville Historic Preservation Commission decided to host the celebration on May 19, 2021 in honor of National Historic Preservation Month.

The celebration commemorated the Lincoln Heights neighborhood and its historical significance to the Town of Clarksville. For many, this was one of the first in-person community gatherings they had been to in over a year. Greg Sekula, Southern Regional Director of Indiana Landmarks, and Jim Kenney, Clarksville Preservation Commission member and former Lincoln Heights resident, led community members down Lincoln Heights' historically preserved pebble streets to learn about the neighborhood's rich past.

Located off Lewis & Clark Pkwy, and sitting between Lincoln Dr., Lynwood and Hibiscus, the neighborhood features homes with distinguished 1940s architecture, picturesque landscaping and original pebble concrete roads — all of which contributed to its historical recognition.

"The building of this community started in 1928 and has filled in since. There are wonderful stories, important people lived here," said Lynn Lewis of the Clarksville Historic Preservation Commission. "The state superintendent of public instruction, the first person to manage Indiana University Southeast, wonderful people have lived here, and so we have great stories to tell about this beautiful neighborhood."

Community members are welcome to take a step back in time and drive through the neighborhood to admire its beautiful architecture and rich history.
