

MINUTES OF A JOINT WORK SESSION OF
THE CLARKSVILLE TOWN COUNCIL AND THE CLARKSVILLE REDEVELOPMENT
COMMISSION
HELD ON APRIL, 2019

A work session of the Clarksville Town Council was called to order on April 2, 2019 at 8:03 P.M. in the Council Chambers of the Clarksville Municipal Center Administration Building by Council President Paul Fetter who chaired the meeting.

Council members present: Paul Fetter, Tim Hauber, John Gilkey, David Worrall, Aaron Stonecipher, Jennifer Voignier and Jaime Hunt.

Discussion of Fire Hydrant Rental

Representatives from Indiana American Water Company presented information on the transition to customer billing of the Hydrant Rental Fees. A discussion was held and it was determined the rate to the customer would remain the same as the town is receiving, pending Council implement and rate lock in prior to the anticipated rate increase in July. Staff were directed to bring this matter to Council for consideration.

Discussion of Health Insurance Renewal

Sandy Halstead with Assured Partners presented options for the council to help reduce the cost of insurance to the town without affecting the benefit or cost to the employee. Discussion was held and staff was directed to bring this matter for Council consideration.

The Session was called to remain open at 8:46 P.M. by Council President Paul Fetter, and the joint session was called to order by Redevelopment President Aaron Stonecipher.

Discussion of the Interlocal Agreement with Jeffersonville and Jeffersonville-Clarksville Flood Control

Jorge Lanz came to the Council and Redevelopment Commission to further discuss the Agreement and request further dialog on the project before terminating the agreement. After further discussion it was agreed to schedule a meeting with the Clarksville Town Council, Jeffersonville Town Council, Clarksville Redevelopment Commission, Jeffersonville Redevelopment Commission, Clarksville Sewer and Wastewater Board, Jeffersonville Drainage Board, Jeffersonville-Clarksville Flood Control, Clarksville Town Attorney, and Jeffersonville Town Attorney. The meeting to be set for April 18, 2019 or April 22, 2019, based on availability.
