

PUBLIC NOTICE: 3.18.2020

The Town of Clarksville is taking measures to keep its employees and the community safe by restricting public access to Town Hall and all Town facilities.

"The core function of government is to protect the health and safety of its residents and visitors. We are embracing this and taking the necessary measures to help curb the spread of COVID-19," said Council President Ryan Ramsey.

Beginning Thursday, March 19, the following procedures are in effect.

- Public access will be restricted to all Town buildings (Town Hall, Police, Fire, Public Works, Wastewater, etc.). Each department will remain open and will be available to address questions or concerns via telephone or email. The Police Department and Fire Station #2 will continue to allow walk-in traffic to their customer service windows.
- Payments for utilities will still be accepted at the utility office through the drive-thru, secure nightly drop box, mail, telephone or through the Town's website.
- Applications for permits and contractor registration can be found online and will continue to be accepted by email or mail. Applications will also be available and accepted through the utility billing drive-thru window.
- All Town of Clarksville public meetings will continue as planned and will be evaluated and announcements will be made on whether they will be held or cancelled. Seating at these meetings may be limited in accordance with State and Federal guidelines.
- All parks and playgrounds are open including Wooded View Golf Course. All restroom facilities within the parks are closed. All baseball and softball fields are closed.
- All Town provided trash service and landscaping debris pickup as well as maintenance of streets and sidewalks, will continue to be provided.
- The Police Department and Fire Departments will continue to operate as normal and will continue to provide for the safety needs of our community.

These restrictions will remain in place until April 13, 2020 and will be re-evaluated at that time.
