# MEET CLARKSVILLE'S NEW REDEVELOPMENT DIRECTOR Nicolas Langford

Nicolas Langford will serve as the Town of Clarksville's new Redevelopment Director, succeeding previous director Dylan Fisher.



Langford has served the Town for more than two years as the Town's Redevelopment Associate. During this time, he has assisted with several prominent redevelopment projects including the Discovery Trail Project, the Town of Clarksville Small Business COVID-19 relief program and other economic stimulus projects to help generate revenue for the Town of Clarksville.

In this new role, Langford will help Clarksville achieve short and long-range goals through strategic planning for future development and redevelopment, with a focus on investment opportunities and branding.

He was selected as Clarksville's Redevelopment Director from a group of more than 20 applicants. Doug Thomas from Strategic Government Resources assisted the Town with the search, interview and selection process.

"We chose Nic, as he is an enthusiastic public servant with ever growing knowledge of real estate development including purchasing, who has developed requests for proposals, and is familiar with our redevelopment process," said Clarksville Town Manager Kevin Baity. "We know Nic can help Clarksville achieve our short and long-range redevelopment goals."

In recent years, the Town has identified opportunities for significant investment and redevelopment along the riverfront in South Clarksville, where the area's economy and culture have been tied to the river for centuries. This includes a push to advance the Riverfront's marketability, livability, and desirability to boost economic opportunities and turn the area into a vibrant mixed-use district with public gathering spaces, walkable streets, bicycle trails, shopping, dining, and entertainment venues anchored by the river, with a dazzling view of the Louisville skyline.

Langford has a Bachelor's degree in Public
Administration from the University of Kansas and a
Master's degree in Public Administration from the
University of Louisville. He began his new role as
Redevelopment Director in January. When he's out
of the office, he enjoys hiking, camping, traveling and
spending time with his family and dogs.



# Q&A

What is your proudest accomplishment while working for the Town of Clarksville?

Discovery Trail, a fantastic quality of life project.

# What upcoming project are you most excited about & why?

I am excited about our South Clarksville project. There is a ton of unexplored potential waiting to be redeveloped into a visionary plan.

### What is your favorite thing about Clarksville?

I'm a big fan of the amazing Mexican restaurants we have around here. They're the best I've had anywhere!

# How has COVID-19 impacted redevelopment efforts in Clarksville?

COVID-19 has increased construction material costs for contractors, changed consumer habits and created some general uncertainty in the market. The pandemic has made me learn to adapt to keep current redevelopment projects on track during fluid times.

# What is the most challenging and most rewarding part of the redevelopment process?

Redevelopment varies so widely that there is not one definitive "challenging" part of the process; however, I think the most rewarding is when a project is in its infancy and you can figure out how to "make it fly." You run multiple feasibility tests and find the one that will move the project forward. That's a cool feeling.

# What did you learn during your time as Redevelopment Associate that prepared you for your new role?

Projects need community support. Ultimately, I am a public servant and need to focus on projects that will serve the public; that can range from developing attractive housing to building out a recreational trail. Regardless of the project, the focus must always be on improving Clarksville and enhancing the lives of our citizens, for current and future generations.

# **COVID-19 VACCINE INFORMATION**

(Updated last on 1/8/21. Please stay up-to-date with the latest COVID-19 vaccine information at www.clarkhealth.net)

- The vaccine has received **Emergency Use Authorization** from the FDA after completing three phases of testing involving 43,000 participants.
- The Centers for Disease and Prevention's (CDC's) Advisory Committee on Immunization Practices (ACIP) has reviewed the vaccine and recommends its use.
- The Indiana Department of Health's external advisory committee of experts has reviewed the clinical trial data and also approves its administration.

The vaccine is available at no cost.


- It is a two-part vaccine, so you must get a second dose after the first dose after 21 days or 28 days, depending on the manufacturer.
- Please continue to wear a mask, stay physically distant and wash your hands even after being fully vaccinated.

We understand that nominal fees during this time will impact our local business community; therefore, we have extended our free initial enrollment period deadline to May 31, 2021.


Annual Renewal Fee: \$30.00 begins June 1, 2021

# **TOWN ANNOUNCES NEW STREET NAMES**

The Town has recently adopted a street grid concept for what will someday become Clarksville's downtown riverfront.

The newly proposed street names will honor the brave members of the Lewis and Clark Expedition to continue Clarksville's rich historical narrative. Learn more about each member below.

### **William Bratton**

Rank: Private

Duties: Blacksmith / Hunter

Birth / Death Dates: 7/29/1778--11/11/1841

**Notable Fact:** While hunting on May 11, 1805, Bratton shot and injured a bear. The bear chased him out of the woods. Upon rejoining the Corps., the group was able to track and kill the bear.

### **John Colter**

Rank: Private

Duties: Hunter

Birth / Death Dates: circa 1775 - 1813

**Notable Fact:** Specializing in hunting and trapping, Colter excelled at his responsibilities and was granted permission to leave the party early and join other trappers in their venture up the Mississippi River. He was also the first white man to visit what is now known as Yellowstone Park.

### Joseph & Reuben Field

Rank: Both Privates

**Duties:** Two of the best marksmen and hunters

Birth / Death Dates: (J) circa 1780 - 1807 (R) circa 1781 - 1823?

**Notable Fact:** Referred to by Lewis as, "Two of the most active and enterprising young men who accompanied us." The Field Brothers excelled as marksmen and hunters within the party.

### **Charles Floyd**

Rank: Sergeant

**Duties:** Appointed one of three sergeants in command of a squad

Birth / Death Dates: 1782 - 1804

**Notable Fact:** Floyd served as one of three commanding sergeants with the main responsibility of shelter and supplies. Eventually, he moved his family to Clarksville where he was the first Clarksville Township constable.

### George Gibson

Rank: Private

**Duties:** Marksman, hunting, etc.

Birth / Death Dates: Unknown - 1809

**Notable Fact:** Gibson was known for being skilled in marksmanship, hunting, interpreting and fiddle playing. He also held the responsibility of maintaining the canoes and boats for the party.



### **Nathaniel Pryor**

Rank: Sergeant

**Duties:** Appointed one of three sergeants in command of a squad

**Birth / Death Dates:** 1772 - 1831

Notable Fact: A man of many talents, Pryor served as a jack of all trades for the Corps. Considered to be "a man of character and ability" by Lewis and Clark, he was able to achieve a high office within the army.

### **George Shannon**

Rank: Private

**Duties:** Hunter

**Birth / Death Dates:** 1785 - 1836

**Notable Fact:** While searching for lost horses, Shannon lost track of the party. Believing he was left behind, Shannon spends many days without food and shelter. Luckily, the party was able to locate him and later named a nearby river after him.

### **John Shields**

Rank: Private

**Duties:** Blacksmith, hunter, etc.

Birth / Death Dates: 1769 - 1809

**Notable Fact:** As a blacksmith, gunsmith, hunter and carpenter, Shields was responsible for maintaining the party's weapons.

### York

Rank: N/A

**Duties:** Hunting

Birth / Death Dates: circa 1772 - 1820s?

**Notable Fact:** Enslaved by Clark, York fulfilled many important duties for the party. During this time, he became the first African American to travel the United States from coast to coast. He also cared for and attempted to save the life of Charles Floyd during the expedition.

# KEEP IT LOCAL: William's Bakery

One of Clarksville's oldest businesses, William's Bakery, opened its doors in 1903. As a full-service bakery offering breads, cakes, cookies, candies, donuts, pastries and more, it's a local staple in the Clarksville community today for its nostalgic charm and famously delicious donuts.

Its distinguishing focus on family tradition is partially why it has been so prominent in the community for so many years, says

Owner Earnest Polston and Wife Debbie Polston. Many families take pride in supporting their favorite local bakery and pass along that heritage to their children.

"It's a family tradition for so many families," said Debbie. "Their children grow up and they start coming in and then their children's children follow the tradition. It's a wonderful thing to see."

Part of some family traditions is to have William's Bakery bake your wedding cake, and the bakery has had the privilege of providing wedding cakes spanning across as many as six generations of a single family.

It's not just a bakery for the locals though. People visiting from out-of-town make it a point to stop by and grab a melt-in-your-mouth pastry or two when visiting Clarksville. Their food items are freshly baked in-house every day, and what doesn't get purchased is donated to the Community Kitchen in Jeffersonville to feed the local homeless community.

Much like many local businesses across the United States, the COVID-19 pandemic has proved challenging for this local bakery; however, the Town of Clarksville was able to provide relief funds by granting William's Bakery a recipient of the Indiana Office of Community & Rural Affairs (OCRA) forgivable loan program.

If you're looking for ways to support your local business community during this time, be sure to visit William's Bakery for its delicious treats and baked goods. The bakery looks forward to serving its guests via curbside, drive-thru and in-person.

# **CENTRALIA COURT**

As part of its project to acknowledge Clarksville's historic neighborhoods, the Historical Preservation Commission recently submitted the Centralia Court subdivision to the state for historic neighborhood designation. While state approval may take as much as two years to complete, we thought you might like to know about this interesting part of our town.




In 1926 the Graham family, through intermediaries F. Shirley Wilcox, Jr. and Ira Wilcox, deeded Part Number 30 of the Illinois Grant to Charles and Theresa Barth, Samuel and Edith Baxter and Irvin and Grace Bence.

The Centralia Court subdivision plat was then laid out with sixteen residential lots delineated on the east side of Gutford Road, then called County Road, and sixteen residential lots on either side of Centralia Court, then called Barth Avenue. Ten lots facing Providence Way, then called State Highway 31W were laid out for businesses.

In 1928, the Baxter and the Bence families built houses in the second block of the plat. Ira and Augusta Wilcox built a house on the same side of the street across what is now Lowell Avenue, a rough alley that the neighbors called "The Ash Road" (so named because the surface of the road was the ashes from their furnaces that the men in the neighborhood spread on the road). The Trinler family then built a home across the street in the first block while the Ruoff family built the home on the hill at the end of the court.

The subdivision was designed to attract well-to-do members of the New Albany community and covenants required that

any house built in the plat had to cost at least \$3,500. In all, thirty-six homes were constructed from the late 1920s to the 1970s with most homes built in the 1930s and 1940s. An early selling point for lots in Centralia Court was that the subdivision lay on the route of the Interurban which connected from New Albany, and New Albany's Glenwood Park, through Clarksville, to Jeffersonville and, after the 1929 opening of the Second Street Bridge, into Louisville.


