

MINUTES OF MEETING OF  
THE CLARKSVILLE TOWN COUNCIL  
HELD ON APRIL 20, 2021

A meeting of the Clarksville Town Council was called to order on April 20, 2021 at 7:00 P.M. in the meeting room of the Clarksville Municipal Center Administration Building by Council President Ramsey, who chaired the meeting.

**Invocation:**

**Recognitions/Appointments:**

-Cary Stemle was appointed to the Board of Zoning Appeals by Council President Ryan Ramsey.

**Public Comments:**

-Dedrick Bland came before the Council expressing interest in starting up a youth football league in Clarksville, since Jeffersonville is no longer hosting the program. Mr. Bland was referred to Parks Superintendent Nelson to discuss details.

**Public Hearing:**

A public hearing was held for an Additional Appropriation for Fiscal Year 2021 for funds: Covid Cares Public Safety Grant, LOIT, CDBG Oera Grant, and Cumulative Fire Fund. No one from the public came forward to speak for or against the additional appropriations.

**Consent Agenda:**

-Minutes of the Town Council Regular Meeting, Work Session and Executive Session held on April 6, 2021, and the Work Session held on April 7, 2021.

-Approval of the Town Current & Pre-written, WW/SW Current & Pre-written, Bonds, Grants and Payroll.

Council Member Stonecipher made a motion to approve consent agenda. Council Member Gilkey seconded the motion and was carried by unanimous vote.

**New Business**

**Approval of Health Insurance Renewal**

The Insurance Committee reviewed the Health Insurance renewal and are making the following recommendations: Accept the HCC Renewal with a savings of 6.25% over last year, accept the Delta Dental updated renewal with an increase of 8.5% over last year, accept the Avesis Vision Renewal with no increase (2<sup>nd</sup> year of a 2 year rate guarantee), and accept the One America (Life and Disability) renewal with a savings of 30.35% over last year, along with a 3 year rate guarantee. Council Member Mustain made a motion to accept the recommendation and approve the Health Insurance Renewal as presented. Council Member Voignier seconded the motion and was carried by unanimous vote.

**Approval of Ordinance 2021-BUD-01, an Additional Appropriation for Multiple Funds**

Ordinance 2021-BUD-01, an Ordinance for an Additional Appropriation for the Covid Cares Public Safety Grant Fund, the LOIT fund, the CDBG Oera Grant Fund, and the Cumulative Fire Fund, was presented to Council. For the first reading, Council Member Gilkey made a motion to approve Ordinance 2021-BUD-01. Council Member Voignier seconded the motion, and was carried by unanimous vote. For the second reading, Council Member Gilkey made a motion to approve Ordinance 2021-BUD-01. Council Member Voignier seconded the motion, and was carried by unanimous vote.

**Approval of Ordinance 2021-S-04, adding a Second Code Compliance Inspector**

Ordinance 2021-S-04, an Ordinance adding a second Code Inspector, was presented to Council. For the first reading, Council Member Gilkey made a motion to approve Ordinance 2021-S-04. Council Member Hauber seconded the motion, and was carried by unanimous vote. For the second reading, Council Member Voignier made a motion to approve Ordinance 2021-S-04. Council Member Hauber seconded the motion, and was carried by unanimous vote.

**Approval of Purchase of Vehicles for Police Department**

Specifications were developed for the purchase of 2021 Dodge Ram Pickups and Durangos, under the Local Business Preference Policy. Quotes were obtained from John Jones, Fletcher and Bachman. After considering all possible discounts, Staff recommends Council approve the purchase of the four (4) vehicles from John Jones at a cost of \$124,900.00. Council Member Hauber made a motion to approve the purchase of the four (4) vehicles from John Jones for \$124,900.00. Council Member Voignier seconded the motion and was carried by unanimous vote.
