

MINUTES OF THE SPECIAL MEETING OF  
THE CLARKSVILLE TOWN COUNCIL  
HELD ON SEPTEMBER 2, 2021

A meeting of the Clarksville Town Council was called to order on September 2, 2021 at 6:15 P.M. in the meeting room of the Clarksville Municipal Center Administration Building by Council President Ramsey, who chaired the meeting.

Council members present: Ryan Ramsey, Tim Hauber, Karen Henderson, A.D. Stonecipher, Mike Mustain, Jennifer Voignier and John Gilkey.

**Invocation:** Invocation provided by Council Member Hauber

**Public Comments:** None

Council President Ramsey announced the first agenda item, Ordinance 2021-G-10. Attorney Fifer introduced Attorney Bergthold, who gave a presentation regarding the adverse secondary effects of sexually oriented businesses, and a summary of Ordinance 2021-G-10 as to why it's necessary, the specific changes the ordinance will make, and the impacts it will have. Attorney Bergthold explained that this update to Chapter 117 follows the June 2019 adoption of Chapter 117 (Sexually Oriented Businesses). He explained that the present ordinance is based upon the same secondary effects documentation as that supporting the 2019 ordinance, which documentation is also made part of the record for this meeting. Attorney Fifer further went on to advise the council regarding the procedures for adopting an ordinance on the same day at the same meeting under IC 36-5-2-9.8(a).

Council Member Stonecipher made a motion to amend Ordinance 2021-G-10 amending Chapter 117 of the Town Municipal Code, by excluding "dealing in controlled substances: from Section 117.11(B)(5) from the text as presented. Council Member Mustain seconded the motion, which motion was approved by unanimous vote of 7-0.

Council Member Mustain made a motion for unanimous consent to waive the rules and consider adoption of the ordinance on a single reading at this meeting in accordance with IC 36-5-2-9.8(a). Council Member Gilkey seconded the motion, which motion was approved by unanimous vote of 7-0.

**Approval of Ordinance 2021-G-10, an Ordinance Amending Chapter 117 of the Municipal Code of the Town of Clarksville.**

Ordinance 2021-G-10, entitled an ordinance amending Chapter 117 of the Municipal Code of the Town of Clarksville, was presented to the Council. Council Member Voignier made a motion to approve Ordinance 2021-G-10. Council Member Hauber seconded the motion, which was carried by a vote of 6-0-1 vote, with Council Member Stonecipher abstaining.

President Ramsey announced the second agenda item is being pulled and will be considered at the September 7, 2021 Council meeting.

**Adjournment**... There being no further business to come before the Council at this time, the September 2, 2021 special meeting of the Clarksville Town Council adjourned at 6:40 p.m.
