A meeting of the Clarksville Town Council was called to order on October 19, 2021 at 7:00 P.M. in the meeting room of the Clarksville Municipal Center Administration Building by Council President Ramsey, who chaired the meeting.

**Consent Agenda:**

Council Member Henderson made a motion to approve consent agenda. Council Member Voignier seconded the motion and was carried by unanimous vote.

**Unfinished Business**

**Approval of Ordinance 2021-ST-02, Establishing 20 MPH Speed Limits in SCMU**

The first reading of Ordinance 2021-ST-02 was read on October 5, 2021, and passed 6-1 with Council Member Gilkey voting nay. Due to the ordinance not passing unanimously on the first reading, a second reading is required. For the second reading, Council Member Mustain made a motion to approve 2021-ST-02. Council Member Henderson seconded the motion and was carried by a 6-1 vote, with Council Member Gilkey voting nay.

**New Business**

**Approval of 2021-Z-09, Rezoning Atlantis Water Park from B-2 (Business) to R-3 (Residential)**

Ordinance 2021-Z-09, an ordinance rezoning Atlantis Water Park from a B-2 to an R-3, was presented to Council. Council Member Mustain made a motion to approve 2021-Z-09. Council Member Gilkey seconded the motion and was carried by unanimous vote.

**Approval of Resolution 2021-R-35, a Resolution Transferring Green Tree Blvd and Veterans Parkway to Clarksville Redevelopment Authority for Bonding Purposes**

Resolution 2021-R-35, a Resolution transferring Green Tree Blvd. and Veterans Parkway to the RDA for bonding purposes, was presented to Council. Council Member Henderson made a motion to approve 2021-R-35. Council Member Voignier seconded the motion and was carried by unanimous vote.
